The only urban Trolley Car Gallery & Cafe in North America is planned for the historic former Public Service Railway property at 1530 Irving Street in downtown Rahway, NJ. The above detail from the design by Steven S. Cohen, Architect PC, Princeton, NJ, shows the projected appearance of the former car shed, built circa 1890, razed in 1926, and to be reconstructed on the site. Inside, two tracks, each 150 feet long, will display six of NJERHS' collection of seven cars. The display gallery will accommodate visitors enabling inspection close-up and boarding of the fully operable cars. At the right, the former Public Service business office, built in 1913, will be restored to its original appearance and refitted to house a cafe/restaurant. In the center above is the Palm Court, where outdoor dining will be offered, weather permitting.







April 2, 1934 finds Line Car 5221 at Bayway, Elizabeth, NJ, (the start of the Fast Line PRW), heading south, dismantling the overhead.

5221 would survive the closure of the PSR Fast Line. First moving to the Elizabeth Car House; then,the Roseville Car House; and the Penn Station Service Shop; and finally, the Bloomfield Maintenance Facility. In each assignment serving as line/utility car. Finally in 2010 she would leave NJT for a new life in the NJERHS Museum/Gallery after 97 years of active service!


